OCFA to Host “Station Open Houses” During National Fire Prevention Week

Annual OCFA RFOTC in Irvine Open House to be held in May, 2017

Irvine, CA – Designated Orange County Fire Authority fire stations will be hosting open houses this Saturday, Oct. 15, 2016, from 9 a.m. to 2 p.m. The station open houses are designed to bring fire prevention awareness to communities during National Fire Prevention Week, Oct. 9 thru 15. OCFA’s station open houses (cities and locations listed below) will give families an opportunity to meet and greet their neighborhood firefighters, tour their local fire stations, and hear about ways they can stay fire safe. The open house at OCFA headquarters in Irvine will be held on May 13, 2017.

The open house theme this year is a reminder to check the date on your smoke alarms, “*Don’t Wait, Check the Date.*” OCFA firefighters are encouraging all residents to check the manufacture dates of their smoke alarms. Most smoke alarm manufacture dates are located on the back of the alarm. If alarms are more than 10 years old, they should be replaced. On Saturday, Oct. 15, come out and visit your local fire stations at the following locations:
