- IQS Qualification System
 - Qualification cards checked on incidents for Level 300 and above positions
 - Qualification cards issued for Level 100 and 200 positions, but they are not checked on incidents
 - The intent of the IQS system is to ensure competency in supervisory / safety related positions
 - The goal is the competency, not the card
 - The system is going “all risk” (not limited to wildland) with all qualifications being listed
 - ROSS is being updated to reflect additional / updated mnemonics
- STPS (Structure Protection Specialist)
 - Taskbook exists, but no curriculum
 - Need for development of curriculum and guidelines for utilization of STPS
- STL (Strike Team Leader)

Strike Team Leader applicants must document a minimum of two assignments, each being three shifts or more in duration. To qualify, each assignment must include all operational phases including demobilization. The idea is for the trainee to experience and demonstrate competency in all aspects of the STL position.
