CALL TO ORDER

The meeting was called to order at 12:00 p.m.

PLEDGE OF ALLEGIANCE

Director Hernandez led the Foundation in the Pledge of Allegiance.

ROLL CALL Director Murray was absent.

PUBLIC COMMENTS

The public offered no comments.

1. CONSENT CALENDAR

On motion of Vice Chair Lowe, and seconded by Director Butterfield the Board approved Agenda Item 1A by acclamation (Director Murray absent).

2. NEW BUSINESS

A. Financial Update

On motion of Vice Chair Lowe, and seconded by Director Butterfield the Board approved staff recommendation by acclamation (Director Murray absent) to receive the Financial Statements and Independent Auditor's Report for the year ending June 30, 2024, confirm the Foundation officers' transfer of program funds as outlined in the staff report, and approve staff recommendation that the Foundation continue to provide financial support for the programs as presented.

On motion of Chair Davert, and seconded by Vice Chair Lowe approved by acclamation (Director Murray absent) to authorize staff to donate \$10,000 to the Fallen Firefighter Fund as a result of a check that was made out to OCFA Foundation, but the requestor noted it was for the Fallen Firefighter Relief Fund.

B. Review and Discuss Proposed Amendments to the OCFA Foundation Bylaws and Implementation Timeline

On motion of Vice Chair Lowe, and seconded by Director Butterfield approved by acclamation (Director Murray absent) to review and discuss proposed amendments to the OCFA Foundation Bylaws and direct staff to develop a timeline for implementing these changes by July 2025. Additionally, instruct staff to provide status updates to the Chair, Vice Chair, and CEO throughout the implementation process and regular updates to the Board.

Director Butterfield commented on the OC Grand Jury tour of OCFA.

ADJOURNMENT - Chair Davert adjourned the meeting at 12:21 p.m.
